## About Indian Political Economy Association

The Indian Political Economy Association is a 30-year-old professional organisation striving to promote political economy in theory and practice in India. It is a Society registered under the Societies Registration Act and the Association came into formal existence in October 1989. One of the primary activities of the association is to conduct annual conferences to gather, interact and proliferate knowledge and develop ideas. The Association has over 700 life members from various parts of the country and has held 25 Annual conferences so far since its inception.

Political Economy has been one of the richest intellectual traditions in social sciences with the objectives to (i) provide a forum of mutual interaction and support to those engaged in theoretical and empirical studies with a view to evolve scientific and socially-responsive political economy with reference to both India and the world (ii) Encourage inter-disciplinary studies and will not restrict itself to the conventional boundaries of individual disciplines (iii) Popularize a scientific understanding of social problems among the people and to contribute to the process of social transformation. The Association has been very active in bringing out publications relating to contemporary socio-economic issues. It has published fourteen high quality edited volumes so far, such as Crisis in India (1995); Emerging Issues in the Political Economy of Development (2014); Plutocracy, Cronyism & Populism: Facets of Neoliberalism in India (2017).

At the intersection of economics and political science, modern Political Economics as a subfield of economics has two aspects to it. Macro political economics deals with political determinants of economic growth and development, politics of public finance, political underpinnings of international trade and financial outcomes, economic determinants and effects of political institutions and outcomes. Micro political economics studies economics of corruption and governance, micro-dynamics of public policies and welfare programs, and the theory and empirics of elections and voting. Modern political economics is aided by sound microeconomic and macroeconomic theories as well as various state-of-the-art statistical and econometric methods deployed on various kinds of datasets such as administrative and survey data. Political economics enlightens us with both big and small but important questions that underlie the role of politics in determining economic and political outcomes.

## Submission of Papers

- The paper should be original and should not exceed a word limit of 9000 words. The format of the paper should follow any standard citation style.
- After a review by the screening committee, authors will be intimated about the acceptance/rejection of the paper by the due date.

- Papers should include an extended abstract of 350-400 words. The abstracts of all accepted papers will be compiled and distributed to the participants.
- **Possible publication opportunity:** We are in talks with two international peer-reviewed journals for a special issue. Selected papers will be considered and their writers will be asked to submit to the journals for further peer review.

It is mandatory to register and pay registration fee for all the participants of the accepted papers before due date. All of the accepted paper participants will receive registration link in the acceptance letter before due date. The registration fee includes provisions for the conference kit, food, transport from the venue to the place of accommodation, access to all technical sessions, and Internet facility at the venue. Those registering after the deadline have to make their own arrangements.

Those going for spot registration have to pay an additional registration fee of Rs 2000.00 (for Indian participants) and \$20 (for foreign participants).

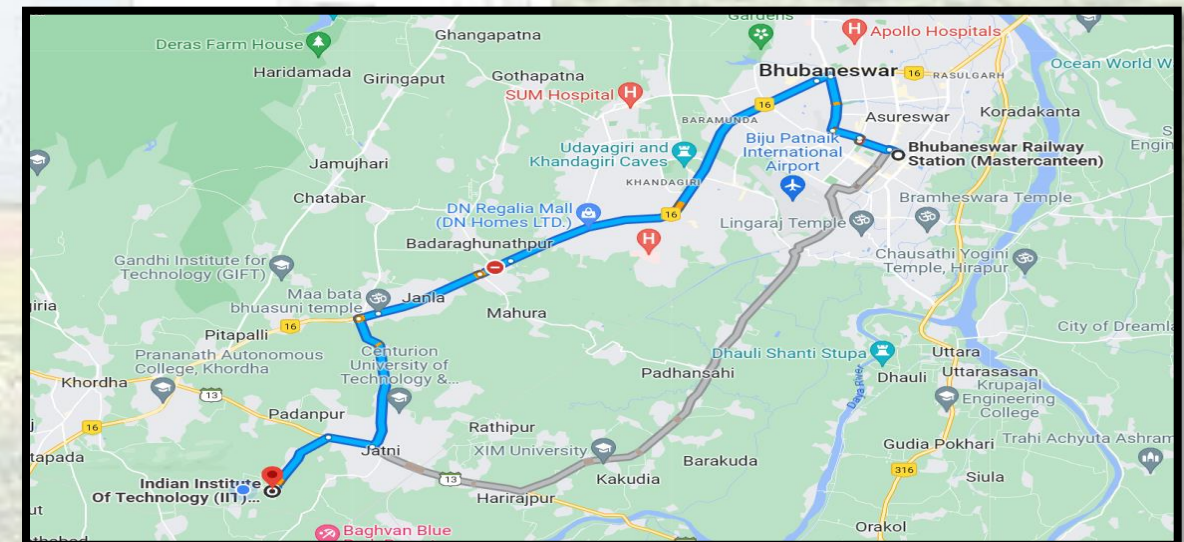
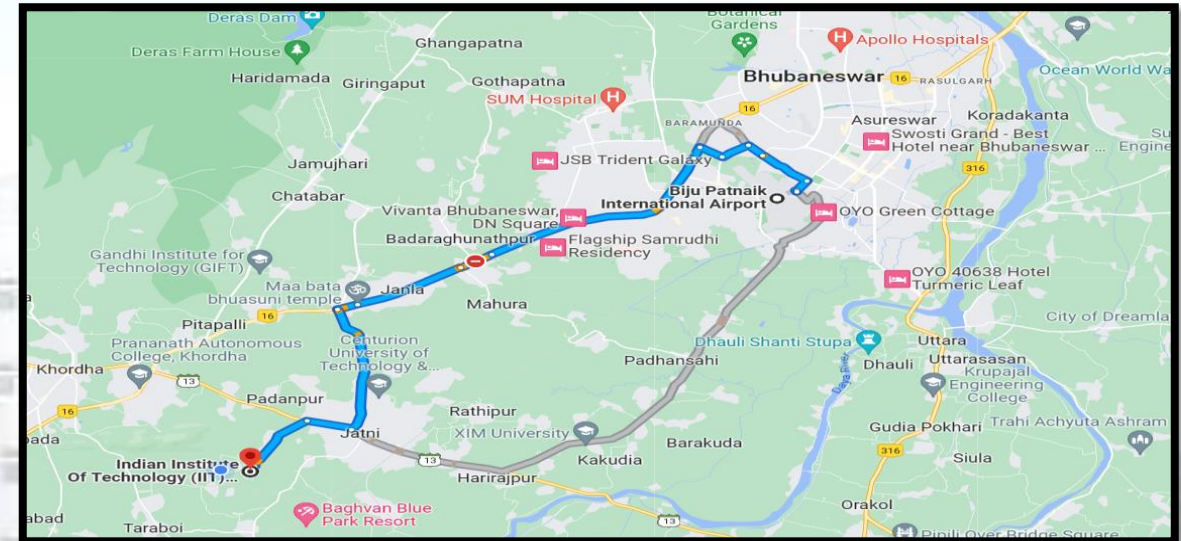
**Reach Bhubaneswar through Rail:** A major railhead on the East Coast (E Co) Railway, it has super-fast train links to Kolkata, Guwahati, Delhi, Chennai, Hyderabad, Bangalore, Thiruvananthapuram, Mumbai, Ahmedabad and other important cities of the country. The station is located in the centre of city.

**Reach Bhubaneswar by Bus / Road:** Bhubaneswar is well linked to the rest of India by the National Highways. The Bus Stand is located on NH5, at Baramunda, about 6 km from city centre.

For visitors interested in sightseeing, buses for Puri and Konark are available from Bhubaneswar at a frequency of around 15 minutes. Buses to Puri and Konark also depart from Kalpana Square, at the top of Lewis Road.
